Old Business:

It needs to be addressed with Dave and the Arena Board that the players/teams are not being pushed off the ice when this does happen. I think Harvey is taking care of this too.

Seaforth Tournament was discussed. Teams are being contacted and info will be posted at the Brussels Tournament.

There is the potential for 4 Co-ed teams again this year in the tournament. We need to confirm so this division can run. Also discussed about teams coming from afar and what demands they have. We will try to accomidate them, but we need to know before the schedule is done up instead of them complaining about it after we have worked on the schedule.
